Funds will be used to purchase an additional sport wheelchair and accessories. Approximate cost \$2,000. The remainder will be deposited to the Wheelchair Tennis restricted account.

- b. Wheelchair tournament at Three Oaks, Feb. 9-10; 28 participants from 11 states
- Facilitated free participation for 52 players and coaches at Madisen's Match, Mar. 18 at FSW.
   Participating schools included Dunbar (11), Island Coast (2), Lehigh Senior (3), NFM (6), SFM (14), Three Oaks Park (16)
- d. Provided tennis racquets, shoes, clothing, windscreens, practice balls, etc. to schools: Dunbar, Island Coast, Lehigh Senior, SFM, Cypress Lake, Challenger Middle
- e. Facilitated two USTA officials' workshops at Three Oaks: May 4 Line School, May 18 Chair School
