TREASURER'S REPORT – SEPTEMBER 30, 2020

STATEMENT OF FINANCIAL POSITION comments;

- The CHECKING ACCOUNT balance at the VALLEY NATIONAL BANK was \$55,085.34.
- The <u>ACCOUNTS RECEIVABLES</u> balance was <u>\$5,345.60.</u> There were no AR items aged more than 61+ days.
- The <u>OTHER CURRENT ASSETS</u>, (prepaid insurance), include *General Liability* coverage for all of 2020 and Litigation insurance for the protection of the LCCTA's Officers and BOARD members for the period from 05/16/2020 through 05/16/2021. <u>The balance of the OTHER</u> <u>CURRENT ASSETS as of 09/30/2020 was \$668.14.</u> This balance will be reduced monthly as premiums are expensed.

The above actions resulted in the **SEPTEMBER 30, 2020 TOTAL CURRENT ASSETS**

balance being \$61,099.08. The Total Current Assets balance at this time last year, (09/30/2019), was \$66,959.52.

- The ACCOUNTS PAYABLES balance was \$6,131.14. All AP items were aged less than 61+ days.
- The <u>RESTRICTED CONTRIBUTION/FUNDING</u> account balance was <u>\$13,223.14</u>. This total amount consisted entirely of contributions, donations and funds restricted for the use of <u>WHEELCHAIR TENNIS programs and services</u>.

The **TOTAL EQUITY BALANCE** as of **SEPTEMBER 30, 2020 was \$54,967.94.** The Total Equity Balance at this time last year, (09/30/2019) was \$64,754.68.
