- The OTHER CURRENT ASSETS, (prepaid insurance) includes GENERAL LIABILITY coverage for all of 2021 and LITIGATION insurance for the protection of the LCCTA' s OFFICERS and BOARD members for the period from 05/16/2021 through 05/16/2022. The balance as of $11 / 30 / 2021$ was $\mathbf{\$ 1 , 0 9 5 . 9 0}$. This balance will be reduced monthly as premiums are expensed.

The above actions resulted in the NOVEMBER 30, 2021, TOTAL CURRENT EQUITY
BALANCE being \$63,289.34. The Current Equity balance this time last year $(11 / 30 / 2020)$ was \$53,023.30.
