E. Program Services

1. Approval, Veterans Park for LCPR Summer Club Rec

Discussion: The Nelson have proceeded with planning for summer Rec for 6 weeks.

6 weeks June 19-July 28, Wed 10-11am, 11am-12pm, teens, Thurs 10-11am, 11am-12pm, 11 yrs and under, 14 campers per session, 2 instructors, \$1,440

Olga Park, July 14, 9-11am, 6-9 yrs, 30 campers, 2 instructors, \$120

2. Approval to increase court reservation usage fee from \$25 to \$35, for USTA and LCWTL teams. Effective 6/1/23.

Discussion: Cost of administering these services. \$25 for Rutenberg and Judd LCWTL teams will not be raised until the 2024 LCWTL season because of their long-term use of these courts.

2. Parks and Recreation –

- a. Mack Young was announced as new Parks Director replacing Jesse Lavender. Kathy Loomis will be Deputy Director in anticipation of Alise Flanjack's retirement in September.
- b. Judd Park court repairs complete as of May 8.
- c. Wa-Ke Hatchee Park has re-opened for outdoor use. No lights for tennis. Facility remains closed.
- d. Lee County Schools will have Middle School Tennis Championships at Rutenberg Park on Monday, May 22 from 5-7:30pm.
- e. Two (2) courts (11,12) at Three Oaks were converted to pickleball courts. 10 tennis courts remain. Facility remains without lights for evening play as a result of Hurricane Ian in Sept, 2022.

3. Tennis Directors – Andrea Nelson, Bob Nelson, Sibo Kangwa

Discussion: Sibo – Three Oaks no lights yet. Full use of courts much of the time. Summer tennis camps planned for Rutenberg and Three Oaks with college players assisting as instructors.

Orlando state high school tournament included a significant number of players competing. One of Sibo's former players competed in the NCAA tournament in Orlando.
